The Buyer agrees that ALL information to be revealed (Including, but not limited to, the Name of firm, Principal(s) of firm, financial reports, asking price; together with the knowledge of such company is for sale), shall remain the property of BDM and will be kept in COMPLETE CONFIDENCE. The Seller(s) also agrees not to release to others, the name(s) of the potential Buyer(s). By signing this document, the undersigned acknowledges BDM's introduction to perspective parties, and fully agrees not to circumvent BDM, or enter into any Agreement directly or indirectly at any time, with the Seller(s) / Buyer(s) or affiliates, introduced by BDM.

Notwithstanding anything contained herein to the contrary. The selling individual(s) and/or selling corporation alone shall be responsible for the fees and compensation paid or payable to BDM; In connection with or relating to the contemplated/completed transaction.
